Assembly Bills

Assembly Bill 140 (BDR 19-63) AN ACT relating to legal holidays; making Juneteenth Day a legal holiday in this State; and providing other matters properly relating thereto.

Status: Passed and signed by Governor.

Assembly Bill 376 (BDR 23-1053) AN ACT relating to state employment; establishing provisions governing paid family leave for certain state employees under certain circumstances; making an appropriation; and providing other matters properly relating thereto.

Status : Passed and signed by Governor , effective July 1, 2023.

Assembly Bill 400 (BDR 34-1088) Revises various provisions relating to education. Section 79 of this bill authorizes the Governor to designate a position in any school district or charter school in this State for which there is a critical labor shortage, thereby enabling such a position to be filled by a retired employee without loss of retirement benefits.

The Retirement Board took a position in opposition to section 79 of this bill at their April 20, 2023, meeting.

Status: Passed and Signed by Governor, Section 79 removed from bill.

Assembly Bill 461 (BDR 23-1075)- Revises provisions relating to the Public Employees' Retirement System. AN ACT relating to the Public Employees' Retirement System; creating the position of Chief Administrative Analyst as a member of the executive staff of the System; and providing other matters properly relating thereto.

Status : Passed and signed by Governor , effective July 1, 2023.

Assembly Bill 518 (BDR 14-1194) AN ACT relating to indigent defense; establishing the maximum amount that certain counties are required to pay for the provision of indigent defense services for Fiscal Year 2023-2024; Section 7.3 of this bill makes an appropriation from the State General Fund to the Department for certain costs related to pretrial release hearings that are or may be conducted on a weekend or holiday

Status : Passed and signed by Governor , effective July 1, 2023.

Assembly Bill 522 (BDR S -1212) AN ACT relating to public employees; establishing the maximum allowed salaries for certain state employees; making appropriations from the State General Fund and State Highway Fund for increases in the salaries of and the payment of retention incentives to certain employees of the State; establishing a plan for continuity of service of certain employees of the State; revising provisions relating to the designation of the Legislative Fiscal Officer; eliminating a certain salary limitation; and providing other matters properly relating thereto.

Status : Passed and signed by Governor , effective July 1, 2023.

Senate Bills

SB14 (BDR 41-259) Makes various changes related to gaming.

The Retirement Board took a position to oppose Section 10 of Senate Bill 14 as written and be neutral if the bill is amended to only provide a very limited re-employment exemption to the Gaming Commission members.

SB431 (BRD 18-1089) Revises provisions relating to governmental administration.

The Retirement Board took a position to oppose Section 3 of the bill as written but with a possible neutral position with proposed amendment.

SB434 (BDR 23-16) Revises provisions related to retirement. Revising provisions governing eligibility for membership in the Public Employees' Retirement System; revising provisions governing the options for service retirement allowances under the System; revising provisions relating to the granting of a divorce; revising provisions governing the disposition of certain pension or retirement benefits upon dissolution of marriage; and providing other matters properly relating thereto marriage; and providing other matters properly relating thereto

The Retirement Board took a neutral position on this bill at their April 20, 2023 meeting.
